- Any person(s) desirous of availing incubation facilities has to incorporate as private/public limited company/start up/ individual entrepreneur(s) under the Indian Companies Act or under DIPP. Government of India and apply in the prescribed format.
- If a company has not been registered, an application may be made in the names of all promoters/ founders; however, the promoters/ founders must ensure that the company is registered within a period of four months from the date of approval of the application for admission in S C Bose Biotechnology Incubation Center.
- The proposed idea for incubation must be as per the thrust areas aforementioned. Innovative or value added technologies especially pertinent to state would be prioritized.

• Applicant shall submit Detailed Business Plan

Criteria for selection of Business plan:

- It should be an innovative idea/Value addition to an existing idea
- Sustainability of the project
- Financial projections
- The usefulness and quality of the business plan concept
- The marketability of the proposed venture
- Community Impact and job creation potential
- The Business Plan will be screened by the Selection/Technical Committee of BIC constituted by CBPS for assessing the suitability of the proposal and its potential for incubation.
- Selected applicants may be invited with their teams to make a presentation on their proposal. In order to enable the committee members to take an appropriate decision, members may ask for any additional information from the applicants and/or revision in the proposal.
- Some representative criteria to be applied for evaluation (not limited to these)
- 1. Strength of the product idea in terms of its technology content, innovation, timeliness and market potential
- 2. IP already generated or the potential of the idea for IP creation and protection thereof.
- 3. Extent of involvement of CBPS faculty, employees, students or any other to access the requirements.
- 4. Strength of the core business team
- 5. Funds requirement and viability of raising finance
- 6. Business model and Break-even projections.
  - CBPS will have a sole discretion whether to admit or reject a proposal for incubation and the decision of CBPS in this regard shall be final. CBPS is not bound to give any reason in case a proposal is rejected.
